State of Somaliland Main Laws as at 30 June 1960

(O - Ordinance; GN - Government Notice; No. - Number)

[Acknowledgement: I have used as a very useful reference the 'Index To the Laws in Force in the Northern Region on 15 August 1960' compiled by Mr Iqbal Singh who worked at the Somaliland Legal Department.]

Introduction

I have listed below the <u>main laws</u> (Acts, Ordinances and Regulations) which were in force as at 30 June 1960. The list is not exhaustive but I have aimed to cover, as far as possible, the main enactments but not their numerous amendments. All the amendments to these enactment up to December 1949 have been included in the three volume compilation of '*The Laws of the Somaliland Protectorate in Force on 1 January 1950*' (which superceded the June 1930 compilation), but the enactments from 1950 to 1960, though published in annual volumes have not been so compiled.

At Somaliland's independence on 26 June 1960 and the coming into force of the independent <u>State of Somaliland Constitution</u>, all the previous laws <u>in force</u> will still be current, but subject their compliance with the provisions of the new Constitution. The Constitution also provided that the Council of Ministers can change any such previous legal provisions that are no longer compatible with the independent status of the country and the interests of the Somaliland people. The relevant constitutional provisions are:

A] Powers of the Council of Ministers to change existing law to conform it to the 1960 Somaliland Constitution: These are set out in the transitional provisions (section 54) relating to existing laws as follows -

Section 54: Existing Laws

- (1) Without prejudice to the repeal or revocation of any existing law with effect from the commencement of this Constitution, the existing law shall continue to be the law of Somaliland as from the commencement of this Constitution except in so far as it is thereafter amended, modified, repealed or revoked by competent authority but shall be construed with such adaptations and modifications as may be necessary to bring it into conformity with the provisions of this Constitution.
- (2) The Council of Ministers may by order published in the Gazette at any time within twelve months after the commencement of this Constitution make such amendments and modifications of the existing law as appear to the Council of Ministers to be necessary or expedient for bringing the existing law into conformity with this Constitution or otherwise for giving effect or enabling effect to be given to this Constitution; and the existing law shall have effect accordingly from such time as may be specified in the order, not being earlier than the commencement of this Constitution.
- (3) An order made under this section may be revoked or amended by a further order made under this section or in relation to any law or instrument affected thereby, by the authority having power to repeal, revoke or amend that law or instrument.

- (4) In this section "the existing law" means the written and unwritten law of Somaliland as it exists immediately before the commencement of this Constitution.
 [Italics added]
- B] The Constitutional provisions relating to how the British & Indian laws and common law shall be applied 'so far only as the circumstances of Somaliland and its inhabitants permit and subject to such qualifications as local circumstances render necessary'. Also courts, in applying the existing laws have to be guided by Somaliland Customary law and by Islamic Law (Sharia). These are set out in sections 42 and 43 of the Constitution, as follows:

Section 42: Application of certain Indian enactments and the law of England

(1) The criminal and civil jurisdiction of the Courts of Somaliland shall, so far as circumstances permit, be exercised in conformity with the enactments set out in the Second Schedule to this Constitution and subject thereto and so far as the same do not extend or apply shall be exercised in conformity with the substance of the common law, the doctrines of equity and the statutes of general application in force in England on the 16th Day of March , 1900, and with the powers vested in and according to the procedure and practice observed by and before the Courts of Justice and Justices of the Peace in England according to their respective jurisdiction and authorities at that date, save in so far as the said enactments and the said common law, doctrines of equity and statutes of general application, and the said powers, procedure and practice have been, or hereafter may be, modified, amended or replaced by any written law made for Somaliland:

Provided always that the said common law, doctrine of equity and statutes of general application shall be in force in Somaliland so far only as the circumstances of Somaliland and its inhabitants permit and subject to such qualifications as local circumstances render necessary.

- (2) For the purpose of facilitating the application of the enactments set out in the Second Schedule to this Constitution -
 - (a) a Court may construe any such enactment with such alterations not affecting the substance as may be necessary or proper in order to adapt the same to the matter before the Court;
 - (b) the Council of Ministers may by order direct by what authority any jurisdiction, powers or duties incident to the operation of any such enactment and for the exercise or performance of which no convenient provision has been otherwise made shall be exercised or performed;
 - (c) any order of the Council of Ministers made in pursuance of this subsection shall be published in the Gazette and shall have effect as from a date to be specified in the order.

Section 43: Courts to be guided by Somali customary law in certain cases

In all cases, civil and criminal, to which only Somalis are parties, every Court shall-

(a) be guided by Somali customary law, (including Somali customary law which is based upon Islamic law) so far as it applicable and is not repugnant to justice, equity and good conscience or is inconsistent with any written law in force in Somaliland or any regulation or rule made thereunder; and

(b) decide all such cases according to substantial justice, without excessive regard to technicalities of procedure and without undue delay.

[Italics added]

It is also important to note that even after the union of Somaliland and Somalia which was nominally on 1 July 1960, the laws in each of the two countries continued in force in their respective territories until common laws were adopted that covered both territories. This was set out clearly in both versions of the Acts of Union. For example the belated 1961 Act of Union states:

'Article 3: Continuation of Laws and Institutions

- 1. The laws in force in Somaliland and Somalia at a the time of the establishment of the Union shall remain in full force and effect in the respective jurisdictions subject the provisions of the Constitution [i.e the Somali Republic Constitution], this law [i.e the Union Law] or any future law. [Italics added]
- 2. Subject to the provisions of Article 94 of the Constitution concerning the jurisdiction of the Supreme Court, and any future Law, the Courts as presently constituted in Somaliland and Somalia shall continue to exercise the respective jurisdiction conferred upon them by law.
- 3. Save as otherwise provided in the Constitution, this law or any future law, all public bodies, both central and local, shall continue to exist and shall retain all their duties, functions and powers.'

Although, after the union, many of Somalia's Italian laws were simply extended to Somaliland in preference to the existing Somaliland laws, the process of harmonisation of laws continued well into the 1970s.

Finally, I have left out various ordinances which, though still in the statute book, were unlikely to have been enforced after independence and fell into disuse quickly or were repealed/replaced by other laws. Examples of these were:

- Political Removal and Detention Ordinance 1910 (No 2/10)
- Undesirable Publications Ordinance 1939 (No 16/39 as amended)
- Undesirable Publications Notices (Various) banning some publications
- Sedition Ordinance 1939 (No 15/39)
- Collective Punishment Ordinance 1949 (No 8/48 as amended)
- Collective Punishment Regulations 1944 (GN 9/44 as amended)
- Political Cases (Attachment of Livestock) Ordinance (No. 3 of 1937)

Some of the provisions of these Ordinances were, however, covered later in the Public Order Law 1963 and in the Penal Code (which came into force in 1964), and of course after the Military dictatorship usurped power in October 1969 and abrogated the Somali Republic Constitution (and the principles of the linked Act(s) of Union), decrees much more drastic than the above Ordinances were routinely issued.
