#### Article 2

Law No. 85/96 of 15/05/1996, Stamp Tax Law, Article 7 of this law was amended and will be read as follows:-

 $\checkmark$  Rate of the stamp tax on invoices, bills, orders ETC, will be 2%

#### Article 3

Law No. 89/96 of 15/05/1996, Body of Laws on Direct Taxations Article 15 of this law, Paragraph (g) is amended and will be read as follows:-L

Temporarily remitted income tax from the emoluments of the members of army forces, until their ranks are established.

### Article 4

Law No. 89/96 of 15/05/1996 -Body of Laws on Direct Taxations. Article 37 is read with article 12 (f) of this law is amended and will be applied as follows:

The rates of income tax applicable to monthly emoluments of the employees and members of the army forces will be as follows:-

1.	up to 90,000 Sh. SL	Exempted
2.	90,001 Sh. SL - 135,000	6%
3.	135,001 Sh. SL - 405,000 Sh. SL	9%
4.	more then 405,000 Sh. SL	12%

#### Article 5

Law No. 89/96 15/05/1996 -Body of Laws on Direct Taxations article12, paragraph (e), is amended and will be read as follows:-

Real Rent of the building will be the real income which is actually received.

#### Article 6

Abrogation

Any law or article contrary to this law is abrogated.

### Article 7

#### Enforcement

This law will be enforceable immediately after the president is signed and published in the official bulletin.
