

This is a copy of the Decree issued by the Deputy Minister of Justice on 30 October 2007 in which he ordered the Ministry of Interior and the Police to eject the current board of SHURO-Net and to install in the offices of the organisation the new board chosen at a meeting he attended on 24th January 2007.

The only legal provision which the Deputy Minister quotes is Article 94 of the Somaliland Constitution which deals with the composition of the Council of Ministers and gives no specific power to the Deputy Minister to issue this Decree.

The second part of this note is the formal response by the Board of SHURO-Net.

In an interview broadcast on 3 November 2007, the Minister of Justice has distanced himself from this decision and was quoted as saying that the Ministry's function is to assist and support human rights organisations.

Shirkaas oo cid kasta oo hunguri ka hayo hogaanka Ururka uu xaq u leeyahay in uu isa soo sharxo si dimuqraadi ah.
